We are pleased to invite you to participate at our upcoming Annual Meeting of Stockholders ("Annual Meeting") to be held on May 25, 2023 at 9:30 a.m., Eastern Time, at our offices located at 312 Farmington Avenue, Farmington, CT 06032. At the Annual Meeting, stockholders are being asked to vote on two proposals, including a proposal to approve a new investment management agreement between the Company and its current investment adviser, Horizon Technology Finance Management LLC ("HTFM").

As described in greater detail in the enclosed proxy materials, our current investment adviser, HTFM recently entered into a purchase agreement to be acquired by an affiliate of Monroe Capital LLC. In order to permit HTFM to continue to provide investment advisory services to us after the closing of the acquisition, stockholders are being asked to approve a new investment management agreement.

We believe the acquisition of HTFM is consistent with our long-term strategy of aligning investment capabilities to create value for stockholders and will benefit us by allowing HTFM to participate in larger investment opportunities, thereby expanding our pool of potential investment opportunities.

We recommend you vote "FOR" each of the proposals.

It is important that your voice is heard, and that you vote at the upcoming Annual Meeting, regardless of the number of shares you own. 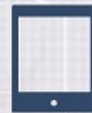
